### **DiRenzo & Bomier Announces Three Affordable Legal Packages for Starting a Business in Today's Economy** *Provides legal elements for forming a company*

The affordable packages have been designed to ensure a business entity is properly organized. In addition to offering the paperwork to form an organization, the firm provides advisors to work through the process and avoid potential pitfalls. The law firm has developed three packages:

- **Budget package** – includes preliminary clearance of proposed corporate name; filing of articles of incorporation; customized corporate by-laws, including officer and director liability protection; organizer's resolutions electing initial directors; resolutions and minutes of the first meeting of the board of directors; subscription agreements; 10 non-customized stock certificates and certificate registers; corporate record book; registered agent services for first year; instruction/educational correspondence to organizers regarding the establishment of financial accounts, the proper use of the corporate name and execution of corporate documents; and consultation with an attorney. The fee is \$130 plus state filing fees.
- **Standard package** – includes all of the components from the budget package plus unlimited customized stock certificates and certificate registers; preparation of federal tax identification application and obtaining tax identification from IRS; preparation of Wisconsin tax identification application and obtaining tax and employer identification numbers from the state; and preparation and filing of S-corporation election and obtaining S-corporation status from the IRS. The fee is \$230 plus state filing fees.

- **Comprehensive package** – includes all of the elements from the budget and standard packages as well as medical expense plan; corporate minutes (forms); stock transfer ledger; free first-class shipping; establishing authority to conduct business in other states; preliminary standard shareholder or voting agreement; and business contract forms. The fee is \$360 plus state filing fees.
